

Bathing regulations for the open-air swimming pool of the municipality of Hohenlockstedt

1. The outdoor swimming pool is a public facility of the Hohenlockstedt community.
2. The stipulations of the bathing regulations are to be observed by the visitors.
3. The entire Lohmühlen area is designated as a landscape protection area. Tents and camping are not allowed. Damage to plants, paths and bank reinforcements as well as the animal world is prohibited and will be prosecuted.
4. The bathing area of the community Hohenlockstedt (Lohmühlenteich) is open daily.
5. Entering the Lohmühlen area and using the Lohmühlen pond is at your own risk.
6. Bicycles, motorcycles and motor vehicles are only to be parked in the designated parking spaces. The community of Hohenlockstedt assumes no liability for this.
7. Orders of the water rescue service are to be obeyed. This is exercised by the DLRG Itzehoe e.V. Complaints must be presented to the head of the DLRG guard station. The supervisory staff can also be the kiosk operator and other persons (representatives of the Hohenlockstedt community).
8. In particular, it is not permitted:
 - a) barbecuing on the Lohmühlen site,
 - b) Bringing animals into the entire bathing area including the lawn (dogs, horses, etc.),
 - c) the use of soaps in the Lohmühlenteich,
 - d) throwing objects into the water surface,
 - e) the pollution of the water and all bathing facilities,
 - f) unnecessary noise or annoyance to guests staying on the premises,
 - g) smoking in the sanitary rooms on the site,
 - h) ball games in the spaces not intended for this purpose,
 - i) Driving on the Lohmühlenteich with boats, with other water sports equipment (especially stand-up paddling) and surfing,
 - j) bathing non-swimmers outside the non-swimmer area.
9. The supervisory staff is authorized to inspect the persons who
 - a) endanger security, peace and order,
 - b) annoy other bathers,
 - c) Despite a warning, violate the provisions of the bathing regulations to expel from the outdoor swimming pool.

Failure to comply with the bathing regulations can result in reports of criminal or administrative offenses. Domiciliary rights are exercised by the community of Hohenlockstedt or authorized persons. It is pointed out that according to Section 3 (3) No. 3 of the Dog Act, it is forbidden to take dogs with you in bathing establishments and bathing areas in surface waters, children's playgrounds and sunbathing areas. It is also forbidden to let dogs run there. Infringements can be punished with a fine of up to 10,000 € according to § 20 Abs. 2 Dog Law.

10. These bathing regulations come into effect with immediate effect. The bathing regulations from May 9th, 2014 are canceled.
